





# **Health Centers with COVID-19 Testing Capacity**




# Health Centers with Walk-up/Drive-up COVID-19 Testing Capacity

# **Sites Temporarily Closed Due to COVID-19**



#### Health Center Staff Unable to Work Due to COVID-19




